## Nautical tourism


## 2021

In 2021, 4 176 foreign vessels for leisure, sports and recreation entered the internal sea waters of Montenegro. Of these, 3 396 vessels sailed by sea and 780 were transported by land.

According to the type of foreign vessels for leisure, sports and recreation, motor yachts (45.1%) entered the internal sea waters of Montenegro the most, followed by sailing yachts (34.3%) and other vessels (20.6%).

The number of persons on board in 2021 was 25 123. According to citizenship, the largest number of persons arriving on these vessels was from Great Britain (6.0%), Croatia (5.9%), USA (3.7%), Scandinavian countries (2.8%), France (2.7%), Italy (2.4%), Germany (2.2%), Austria (1.9%), Switzerland (1.3%), and other countries (71.1%).

Graph 2. Number of vessels by flag, 2021




## **METHODOLOGICAL NOTES**

The aim of the statistical survey on nautical tourism is to obtain data traffic from foreign yachts and other vessels intended for leisure. sport and recreation in the territorial sea of Montenegro. as well as the number of persons on board who enter our country. Reporting units in this survey are harbour master's offices and their branch offices. Data collection is carried out using the reporting method (TU-17 form).

Motor yacht is a vessel equipped with an engine intended for entertainment. sport or recreation and having according to the common maritime usance. a cabin with at least two beds. a toilet and cooking facilities.

Sailboat is a vessel intended for entertainment. sport or recreation whose main power is wind and it is equipped with a cabin with at least two beds. a toilet and a cooking facility.

Other vessels are boats (made of wood. plastic. rubber and the like) 3 or more meters long or less than 3 meters long if they are equipped with an engine. Included are also motorboats if they do not meet requirements for yachts.

The last published data are considered preliminary. and becomes final within the defined deadline. as forseen by the Statistical Release Calendar.
