Number of trans-shipped (reloaded) tones in the third quarter 2014 compared with the same quarter of previous year decrease 21.0%.

Number of manipulated tones in the third quarter 2014 compared with the same quarter of previous year increase 21.1%.

Graph 1. Trans-shipped and manipulated tones

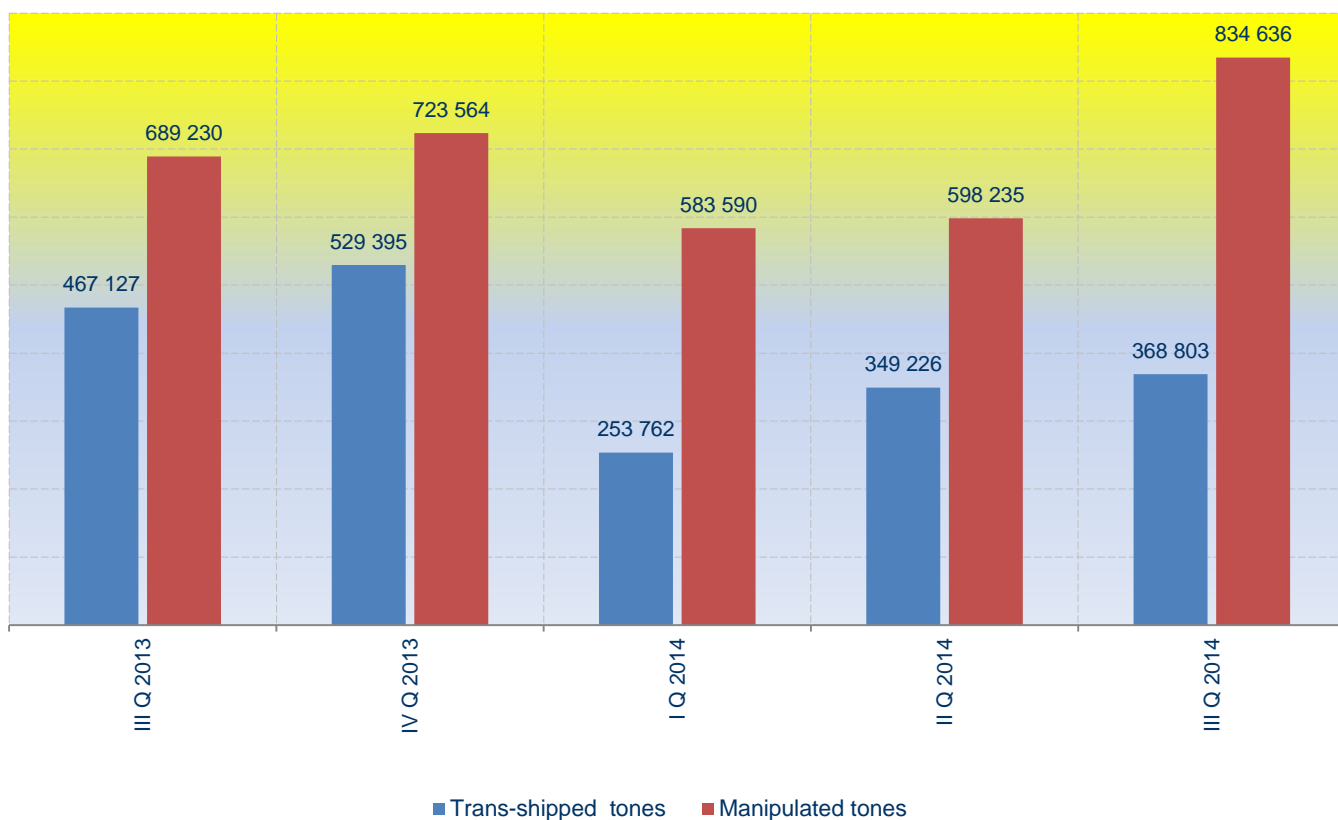

METHODOLOGICAL NOTES

Source of data

Data on transshipment are the result of regular quarterly surveys reporting units whose activity cargo handling (loading and unloading of ships in them) the main activity.

Coverage

The surveys cover enterprises classified within the classification unit register by activity classification in section H (Transport and storage), Area 52.

Definitions

Trans-sipped tons of cargo related to the total amount of cargo that passes through the transshipment business entity, where the same load, regardless of the number of manipulations that it has executed, shown only once.

Manipulated tons are a unit of performance that expresses the sum of operations registered by kind that are made (unloading, loading, reloading the direct transfer).
