Introduction

Statistical Office of Montenegro - MONSTAT builds contemporary statistical system that helps Montenegrin statistics to be comparable with international statistics and statistical methodologies.

Related to that MONSTAT made revision of foreign trade data for period 2005-2009 .The reason of revision is harmonization with running EU standards. Data are processed using special trade system, import data are recorded based on country of origin. Difference in data is because of changes in trade system, updated data base for revised period as well as recording import by country of origin. In this way data from 2005 to 2009 are completely comparable.

METHODOLOGICAL GUIDANCE AND SOURCES

For statistics of trade of goods with foreign countries there are several methodological bases: recommendations of UN Statistical Office, EU custom regulation, EUROSTAT methodological materials. These recommendations, regulations and materials offer methodological guidance and serve as base for harmonization of this statistics to international standards and there are complemented with our national regulations related to trade of goods with other countries.

Making of trade of goods data is based on following publications:

- International merchandise Trade Statistics, Concept and Definitions, UN
 - Statistics on the Trade of Goods, User Guide, EUROSTAT
- Work is harmonized with COMMUNITY LEGISLATION applicable to the STATISTICS RELATING TO THE TRADE OF GOODS, related to EXTRASTAT
- Council Regulation 1172/95
 - Commission Regulation (EC) No. 1917/2000
 - Regulation (EC) No.471/2009 of the European Parliament and Council
 - Commission Regulation (EC) No. 113/2010

Regular monthly statistical survey „Economic relation with foreign countries” is done based on Law on statistics and statistical system of Montenegro (Official Gazette of Republic of Montenegro 69/05) and Program of Statistical Survey CG for 2009 -2013 (Official Gazette)

Source of data

Source of data for statistics of Montenegrin trade of goods are customs declaration on export and import of goods. Customs declaration is document used in customs procedure. It contains data important for customs procedure but also for statistical needs and other users needs.

Customs Administration of Montenegro is responsible for collection and control of the accuracy of customs declaration, which prescribe content, type, way of filling in and the way of submitting of customs declarations in customs procedure. MONSTAT in monthly periodicity takes data in electronic form from Customs Administration of Montenegro and follows to process them statistically and publishes the results.

In customs procedure of Montenegro it is applied:

- Customs Law (Official Gazette 7/2002, 38/2002, 72/2002, 21/2003, 29/2005, 66/2006 and 21/2008)

Based on Customs Law it was made:

- Regulation of type, content and the way of submitting customs declaration and collective registration form

(Official Gazette 03/2003 i 08/2007) and many other instructions.

In customs procedure from 2002 during tariffing of the products it is used Combined nomenclature which is harmonized with EU Combined nomenclature. It is published annually in Official Gazette for current year.

Foreign trade coverage

According to Article 3. Regulation (EC) No.471/2009 and Article 6. Of Council Regulation 1172/95 foreign trade includes following definitions.

Export covers the goods leaving the statistical territory of Montenegro in accordance with the following customs procedures:

- a) Export
- b) Outward processing
- c) Re-export that was in the procedure of inward processing and manufacture of goods under customs control

Import covers all goods entering the statistical territory of Montenegro in accordance with the following customs procedures:

- a) Import for free trade
- b) Inward processing
- c) Manufacture of goods under customs control
